##### *Teams*

The Diadora Cup was a success for EMFC. Mac will re-evaluate the Diadora Cup for next year. We will look at the competition level at Oregon tournaments before committing to Washington tournaments.

Summer Day Camp starts next week. Looking at about 30 kids. Lots of competing camps out there.

Little Metros start next week training for the Salem Waterfront Tournament. We will possibly be taking them to the Chinook Cup as well. Shane has a calendar plan for Little Metros. Shane Dasher was here to explain his plans for Little Metros to the board. There is general discussion about the relationship between EMFC and KidSports. Discussion about what type of player we will try to attract and what type of player KidSports attracts. Shane is looking to do a soccer league within the Little Metro program. We are looking at how to market the program to attract players as well as provide games to the kids either through KidPSorts teams or through Little Metros.

Guy was able to reserve a number of fields at the City of Eugene. We have fields reserved for every night of the week.

##### *High School Tryout Planning*

Setup to do tryouts for HS aged teams the week after PQT's. We will have to days of tryouts at Monroe Middle School. All players will have to attend both days of tryouts. Informational meeting is also set. Mac has coaching assignments set. Mac has also met with the Blue Crush and they will be coming to the club as a U16 Girls team. Mac is expecting a very competitive tryout for all HS teams.

Flo will talk to the register guard and get an announcement in the paper we will also look to Bi-mart to place an add as well.

Mac is concerned about player commitment at the HS level. We will be taking steps to ask for a financial commitment as well as a player commitment.

Mac is projecting at least 4 teams possibly more.

### *Summer Programs*

EMFC is hosting a "D" license clinic for coaches. Mac and Jurgen will also be holding EMFC coaching clinics throughout the summer. The "C" and "B" licenses are national licenses and the coaches will have to travel. We will be looking at helping EMFC coaches attend these clinics.

Bill Dennehy sent out a report on the 7 v 7 tournament and would like to come to the next meeting to go over his report. Financially, the tournament over performed. We made more than we had planned and had more teams registered than we projected.
